The Dimock Center Receives \$2.5 Million Grant from the Yawkey Foundation to Expand Critical Addiction Treatment Services in Boston

Lead gift to \$18 million campaign will create Boston's first and only men's postdetox clinical stabilization services (CSS) program

Roxbury, MA – March 14, 2023 – The Dimock Center is pleased to announce that it has received a \$2.5 million grant from the Yawkey Foundation to support the development of a new 32-bed post-detox, clinical stabilization services (CSS) unit that will serve more than 1,000 people annually who have completed inpatient detox for substance use disorder.

The grant will allow for the renovation and expansion of the historic Dr. Marie E. Zakrzewska Building, a focal point of The Dimock Center's campus, to house Boston's first post-detox clinical stabilization program for men. The building will also be renovated to accommodate The Dimock Center's existing women's clinical stabilization program. Together the 16-bed men's and 16-bed women's programs will reach more than 1,000 people annually.

"Coordinated care during the critical post-detox period is vital to helping people sustain recovery. After patients leave detox, they are particularly vulnerable to relapse unless they have adequate support services," said Dr. Charles Anderson, President and CEO of The Dimock Center. "There are currently no post-detox, clinical stabilization treatment beds for men in Boston. This grant from the Yawkey Foundation, our longstanding partner, will allow us to fill this gap and increase the likelihood of successful recovery by allowing people to stay within their community for their entire substance use treatment journey."

"The Dimock Center's unique model of providing holistic services for healing on a single campus increases the likelihood of a successful recovery with the goal of saving more lives," said Maureen H. Bleday, CEO and Trustee of the Yawkey Foundation. "The commitment to excellence and compassion with which The Dimock Center delivers a continuum of care—with dignity and respect—directly reflects the charitable values that guided Tom Yawkey and Jean Yawkey during their lifetimes, which the Trustees of the Foundation continue to honor with this gift."



The Dimock Center and the Yawkey Foundation have been partners for 25 years. The Yawkey Foundation began supporting Dimock in 1998, and since then has provided \$3.65 million in grants. Among past grants was a \$2.5 million lead gift in 2015 to renovate the Dr. Lucy Sewall Center, transforming the historic building into a state-of-the-art center of excellence for acute addiction treatment services.

About The Dimock Center's substance use disorder treatment services

In Boston, opioid-related deaths are up by 37% since 2018¹ and Massachusetts exceeds the national average in the rate of drug overdose deaths.²

The Dimock Center is on the front lines of the substance use epidemic, helping thousands of men and women each year on their journey to recovery. The Dimock Center currently offers counseling and addiction services, an inpatient detox center for men and women, a women's clinical stabilization services unit, and multiple residential programs for men and women.

In 2018, The Dimock Center opened the Dr. Lucy Sewall Center for Acute Treatment Services, a medically monitored detox unit for alcohol and opioid use disorders, which increased inpatient acute treatment beds from 30 to 39 beds, reaching an additional 1,000 people annually for a total annual ability to serve 4,000 people.
